- identify the 3 main principals of motivational interviewing: Don't tell what to do, Listen and Support.
- define the acronym FRAMES that is used for MI during the screening process.
- develop the ability to effectively intervene with those who are at moderate or high risk for psychosocial or

Goal: The goal of this presentation is to learn about assessment sites in Bucks County, learn about the drug and alcohol levels of care, the assessment process, and the impact of co-occurring D&A and mental health issues.

- explain the D&A assessment process, including the role of the American Society of Addiction Medicine (ASAM) Placement Criteria.
- develop an understanding and knowledge about the impact of co-occurring D&A and mental health issues in treatment.
- recognize the specific areas of substance use in Bucks County for Transition Age Youth as reported in the PA Youth Survey of 2019.
- demonstrate a basic understanding of the Stigma related issues and their impact on treatment recommendation acceptance.

- demonstrate their knowledge base to effectively:

- Screen and provide brief advice or referral to youth who present with a varying history of ATOD use/ abuse.
- Influence risky behavior patterns and reduce exposure to the negative consequences of ATOD use/misuse/abuse.
- Utilize linkages between various community providers and specialized substance abuse providers to facilitate access to care when needed.
- Utilize motivational interviewing (MI) techniques while administering and reviewing SBIRT screening tools with the population served.
